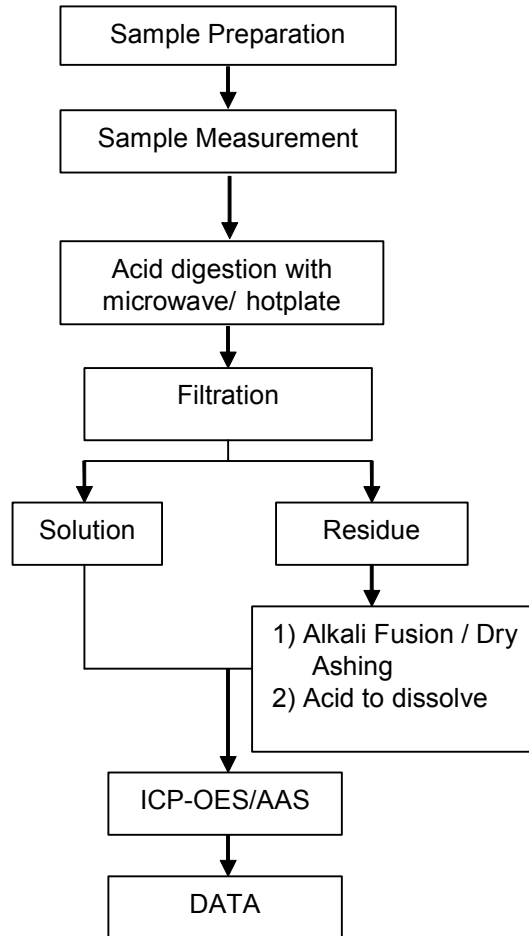

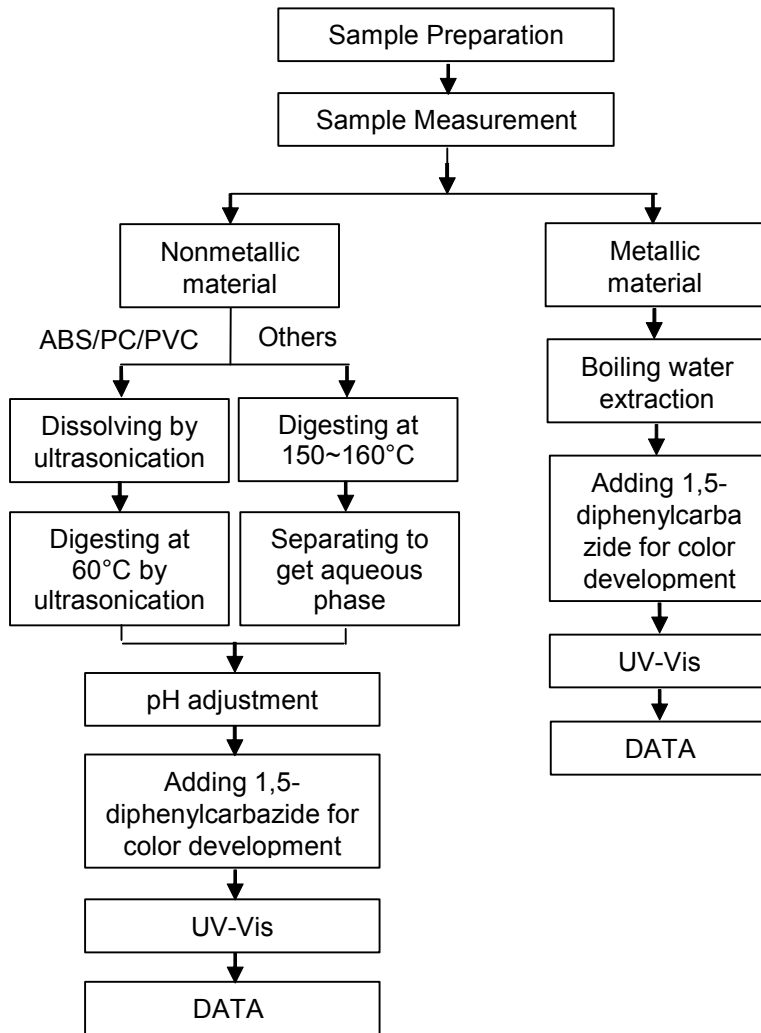

Hexavalent Chromium (Cr(VI)) Testing Flow Chart

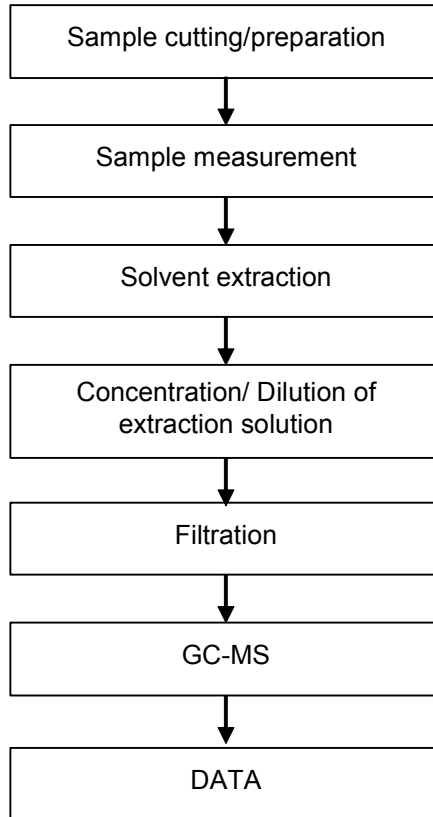

Flame Retardants Testing Flow Chart

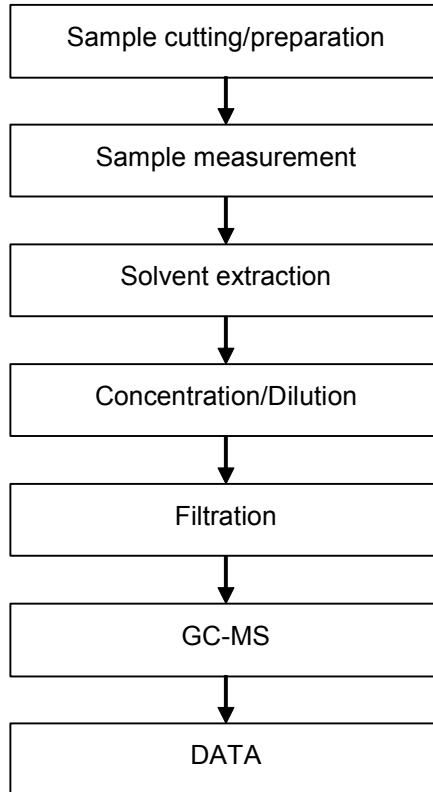

**Phthalates Testing Flow Chart**



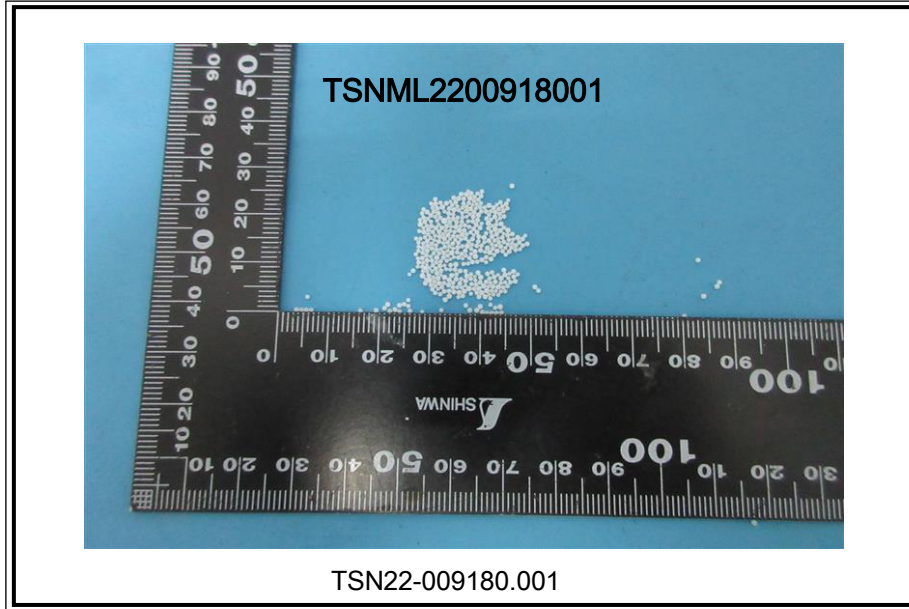
